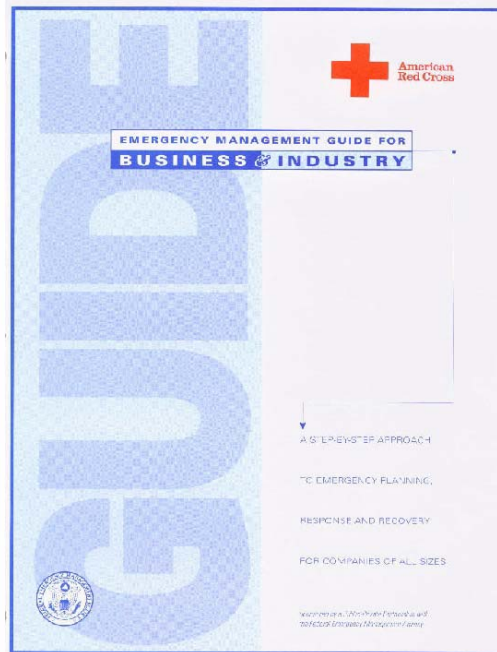
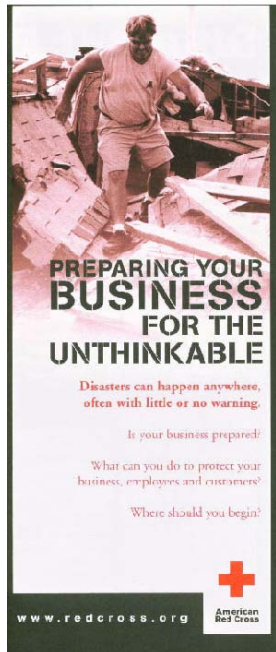

DISASTER PREPAREDNESS
Waikoloa Seniors, July 16, 2001 9:00 a. m.

INTRODUCTION: (Myself)

OBJECTIVES:

1. Understand the need for Disaster Preparedness & Planning and what you can do to better safeguard yourself & your family.
 2. Provide useful Information on two specific hazards in your community: residential fires & hurricanes
 3. Provide useful Information on what a Family Disaster Plan Is and how to create one: The Four Steps to Safety
1. DISASTER PREPAREDNESS
- Disasters can strike quickly & with little or no warning (fire, flood, hurricane, tsunami, earthquake, volcano, blackout, hazmat)
- Individuals & communities can become isolated: basic services may be unavailable: emergency workers may not be able to reach everyone right away.
- Goal of Disaster Planning: Lessen Impact, Better cope, Recover more quickly
- Knowing risks & hazards - taking steps to mitigate (prevent or lessen the Impact) & planning what to do in advance is your best protection and your responsibility.
2. SPECIFIC HAZARDS
- Let's look at two specific hazards that you in your community may face: Residential Fire and the dangers associated with a hurricane
- RESIDENTIAL FIRE: (how to plan ahead and be prepared to deal calmly with a fire)
- a. Fires can happen unexpectedly but you can prevent and prepare if one should occur.
 - b. One of the most common disasters - more 2 million/yr US c. Most people die as a result of asphyxiation
 - d. Need to have a home fire plan e. Make your home "Fire Safe"
 1. Smoke detectors
 2. Fire extinguisher in kitchen
 - f. Plan escape routes (2) and identify a meeting place
 - g. Make or purchase rope or chain ladders & practice using
 - h. Conduct periodic fire drills
 - i. If fire starts, keep low ; check doors for heat/close doors behind you; stop/drop/roll (prone & cover eyes)
 - J. Goal is to get everyone out safely; once everyone is out, call fire dept.
- HURRICANE: (introduce video, "Storm Alert.") Questions and reinforce message
- a. What are the two most important precautions you can take? EMERGENCY PLAN AND FAMILY SUPPLY KIT
 - b. What is Hurricane's Triple Threat?
STORM SURGE, RAIN & FLOODING, HIGH WINDS
 - c. What is Civil Defense emergency signal? What should you do?
3 mi. loud steady tone: tune into radio/tv emergency broadcast
 - d. What is difference between hurricane watch & warning?
36 hours & possibly 24 hours or less & imminent
 - e. What are some things you should have in your emergency supplier kit?
portable radio, first aid kit, food, water, medications, pet supplies, change of clothing, bedding, batteries, flashlights, etc.
- f. After the storm, what should you do?
wait for further instructions, stay off roads, check home for safety, watch for broken glass, downed electrical lines, etc.
3. FAMILY DISASTER PLAN (WHAT CAN YOU DO?)
- Four Steps to Safety
1. Find out what can happen to you
What types of hazards & how to prepare for each
Know your community warning system & how to get information
What about animal care?
Special needs (elderly & disabled)
Are there disaster plans at your workplace, your grandchildren's school and what are they?
 2. Create your plan
Meet with your family to discuss what to do Pick two places to meet
Develop an emergency communication plan (in case you become separated)
Out of town Family contact
Know where shelters are located if evacuation is necessary; know what you need to shelter in place
Know your evacuation routes
Remember your pets
 3. Complete your checklists
Post emergency numbers Know how to turn off the water, gas, & electricity if necessary
Check your insurance coverage
Install smoke alarms
Purchase and learn how to use a fire extinguisher
Conduct a home hazard hunt (include safety issues for elderly)
Stock emergency supplies and assemble a Disaster Supplies kit (keep smaller supply kit in car)
Portable battery-operated radio & extra batteries
Learn First Aid & CPR
Plan home escape routes
Photocopy vital documents keep copy in safe deposit box; use waterproof safe in home; including home inventory with photos, description, & serial numbers
 4. Practice & update your plan regularly
Make sure all members of your family know what to do
Take responsibility for yourself and keep in touch with neighbors to look out for each other.
- REVIEW AND STRESS KEY POINTS FOR ELDERLY
- Don't forget: Prescription Medications
Extra eyeglasses and hearing aid batteries Extra wheelchair batteries, oxygen information on medical devices - style & serial number (such as pacemakers)
List of doctors and relative/friend who should be contacted if you are hurt
Medical insurance and medicare cards Information on health status, any allergies, etc.
Identification
Planning for Pets
Back up power supply if needed

5.1 Meetings/Presentations-- trained 500 volunteers from March 2001 to July 2002

5.2 Course Descriptions

American Red Cross
West Hawaii Branch.
Disaster Services

Introduction to Disaster Services: (3 hours)

Provides basic information about disasters and their effects. Outlines roles of agencies in disaster relief and introduces participants to Red Cross Disaster Service structure. Video and Instructor presentation. :NOTE: This course is a prerequisite to all other disaster service training.

Prerequisite: None

Damage Assessment: (3 hours)

Trains participants how to obtain and report damage assessment information and provide operational support on disaster relief operations.

Prerequisite: Introduction to Disaster Services

Mass Care: An Overview: (3.5 hours)

Provides basic information about the activities of the Mass Care function.

Prerequisite: Introduction to Disaster Services

Disaster Shelter Operations: (3 hours)

Prepares participants to effectively and sensitively manage shelter operations as a team to meet the needs of people displaced as a result of a disaster.

Prerequisite: Introduction to Disaster Services

Family Service: Providing Emergency Assistance: (8 hours)

Trains participants to meet the emergency needs of disaster victims following a disaster in either a chapter or national setting. Helps participants to develop interviewing skills, knowledge, attitudes, and relationships necessary to meet the disaster caused needs of individuals and their families.

Prerequisite: Introduction to Disaster Services

Note: The above courses (and Basic First Aid and CPR instruction) are required for members of Disaster Action Teams

Disaster Health Services I: (8 hours)

Trains participants to organize and administer the Disaster health Services function on a chapter level and to initiate health services on a larger relief operation. Course is designed to help participants identify disaster health services preparedness measures that should take place on the chapter level and become familiar with the policies, regulations and procedures that apply on all chapter administered disaster operations.

Prerequisite: Introduction to Disaster Services and current Hawaii licensure.

Disaster Mental Health: (16 hours)

Training for this course is designed to prepare participants by providing the interventions necessary to meet the immediate disaster-related mental health needs of Red Cross workers, their families and disaster victims in accordance with disaster services regulations and procedures.

Prerequisite: Introduction to Disaster Services , current Hawaii licensure, and application 5898H
