AN ORDINANCE AMENDING CHAPTER 24 OF THE HAWAII COUNTY CODE OF 1983, AS AMENDED, RELATING TO VEHICLES AND TRAFFIC (This bill prohibits the use of coasters, roller skates, roller blades, skateboards, and other similar devices within the Kailua Village commercial area, makai of Kuakini Highway; between Palani Road on the north; extending southbound on Alii Drive to the intersection with Walua Road on the south; and further included Hualalai Road westbound to the intersection with Alii Drive, and all public areas located on the Waiakea Peninsula, makai of Kamehameha Avenue-Kalaniana'ole Avenue from the Wailoa River estuary to the site of the former Reeds Bay Restaurant (TMK – 2-1-06: 11, 12, 19 and 20)

From Legislative Analyst Gerald Monden, dated August 9, 2000, transmitting the above bill, per request of Councilmember Bobby Jean Leithead-Todd.

Recommends Bill 309, as amended to Draft 2, pass first reading.
