States the incorrect interpretation of their "Auction Blimp" causes undue and inequitable hardship and may be construed as discriminatory when economic damages are considered. Flying the blimp is subject to weather conditions and it is stored in their warehouse nightly and on inclement days. Informs they have complied with FAA regulations.
