(Bill 101) AN ORDINANCE AMENDING ORDINANCE NO. 01-56, AS AMENDED, RELATING TO PUBLIC IMPROVEMENTS AND FINANCING THEREOF FOR THE FISCAL YEAR JULY 1, 2001 TO JUNE 30, 2002 (adding \$61,195 to the Capital Budget for the Hawaiian Paradise Park Volunteer Fire Station-Water Main project)

From Director of Finance William Takaba, dated September 6, 2001, transmitting the above bill. Funds for this project lapsed on June 30, 2001 but work on this project is still incomplete. Funds must be reappropriated to continue and complete this project.

(Bill 104) AN ORDINANCE TO AMEND ORDINANCE NO. 01-55, AS AMENDED, THE OPERATING BUDGET FOR THE COUNTY OF HAWAI'I FOR THE FISCAL YEAR ENDING JUNE 30, 2002 (appropriating a \$50,000 Public Housing Grant from the State Department of Business, Economic Development & Tourism's Housing and Community Development Corporation of Hawai'i)

From Director of Finance William Takaba, dated September 11, 2001, transmitting the above bill. This grant will help defray personnel and equipment costs for the community police officers in the Ka Hale Kahalu'u, Kaimalino and Kealakehe public housing areas and other neighboring communities with their proactive crime and drug prevention programs.

Comm. 347:
(Bill 105) AN ORDINANCE TO AMEND ORDINANCE NO. 01-55, AS AMENDED, THE OPERATING BUDGET FOR THE COUNTY OF HAWAI'I FOR THE FISCAL YEAR ENDING JUNE 30, 2002 (appropriating a \$109,994 Local Law Enforcement Block Grant from the U.S. Department of Justice's Office of Justice Programs for purchase of eighty-six (86) computer workstations for use with the proposed Records Management System)

From Director of Finance William Takaba, dated September 11, 2001, transmitting the above bill. This system will focus on improving the quality and completeness of data collected and should provide the uniformed field officers with enhanced investigative capabilities.
