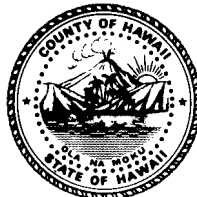

Ms. Susan Shirachi Gonsalves of Council District 1 is a 33-year resident of Hawai'i and is currently employed by the University of Hawai'i at Hilo as the Americans with Disabilities Act Coordinator and Disability Services Director. She is also a member of Disability Rights Hawai'i and the East Hawai'i Coalition of Youth. Not affiliated with any political party, she will serve a term to expire on December 31, 2005.

Ms. Sarah K. Togashi of Council District 3 is a lifelong resident of Hawai'i and is retired from service with the County and State of Hawai'i. Ms. Togashi is currently a director of the Hilo Lions Club and secretary for the Kea'au/Kula Kumiai. She is also a member of the W.H. Shipman Advisory Commission and the Kea'au Nutrition Center. A member of the Democratic party, she will serve a term to expire on December 31, 2005.
