(Bill 92) AN ORDINANCE AMENDING CHAPTER 20 OF THE HAWAI'I COUNTY CODE 1983 (1995 EDITION), RELATING TO REFUSE DISPOSAL, TO PROHIBIT THE COMMERCIAL DISPOSAL AT COUNTY SOLID WASTE FACILITIES OF REFUSE IMPORTED FROM OUTSIDE THE COUNTY OF HAWAI'I (Establishes a ban on the disposal of any rubbish, prohibited materials or refuse which has been generated outside of the County of Hawai'i and brought in to the County of Hawai'i for disposal in our landfills)
