AN ORDINANCE AMENDING CHAPTER 24, OF THE HAWAI'I COUNTY CODE 1983 (1995 EDITION), RELATING TO VEHICLES AND TRAFFIC (Adds a Passenger Loading Zone on Kapi'olani Street, mauka side, beginning from a point forty-nine feet Puna of the Veterans Cemetery Access Road and extending one hundred ninety-six feet in the Puna direction from 7:15 a.m. to 8:00 a.m. and from 2:30 p.m. to 3:30 p.m. on school days – Mauna Loa School)

From Deputy Director of Public Works Jiro A. Sumada, dated January 17, 2001, per request of Mr. Alan Lipps, Principal of Mauna Loa School, for a passenger-loading zone to improve overall safety for students and motorists during the morning and afternoon loading and unloading activities, transmits the above described ordinance bill.
