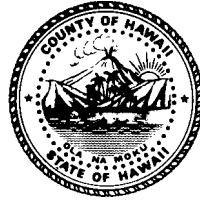

(Bill 37) AN ORDINANCE AMENDING CHAPTER 21-36.1 OF THE HAWAI'I COUNTY CODE 1983 (1995 EDITION), RELATING TO WASTEWATER SERVICE CHARGE RATES
From Environmental Management Director Barbara Bell, dated December 26, 2002, transmitting the above bill. The current user fees were developed based on the assumption that the administration portion of the Operating Budget would be funded through the General Fund. However, since FY 1999-2000, the Wastewater Division has been required to fund all operating costs including operation, maintenance, equipment replacement and administration expenses exclusively through user fees.

This bill increases the Wastewater Service Charge rates contained in Section 21-36.1. Effective July 1, 2003, Single Unit Residential rates will be raised from \$27 to \$36 and incrementally to \$40 per unit by July 1, 2007; the Multi-Unit sewer rates will be raised from \$27 to \$28 per unit; the Non-Residential base rates will be raised from \$22 to \$24, and incrementally to \$28 per unit by July 1, 2007, (the monthly usage charge per 1,000 gallons [after the first 7,000 gallons] being raised to \$4.20 per unit on July 1, 2007); the Gang Cesspool rates will be raised from \$15 to \$23; the private haulers' discharge fees will be modified with the maximum charge per load being raised from \$30 to \$40; and a charge for recycled water will be established.
