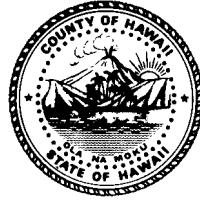

Last fiscal year, the U.S. Department of Transportation, through the State of Hawai'i Department of Transportation, Public Affairs Office, Safe Community Program, provided a \$15,000 Traffic Investigation Program Grant to increase the quality of alcohol and speed related traffic fatality investigations by providing training and equipment to police officers. This year, an additional funding of \$6,800 is being supplemented to that grant for travel expenses to attend and participate in the Statewide Traffic Investigation Training to be held on Maui. This will bring the total grant amount to \$21,800.

The funding for this position is being provided by the State of Hawai'i Department of the Attorney General's Victims Services Coordinator Grant and is already appropriated in the County's Operating Budget.

- From Mayor Harry Kim, dated July 21, 2004, transmitting the above bill. States that \$363,221 represents part of the Sort Station funding that was removed from the proposed budget. The Sort Station is not proceeding at this time, as directed by the Council. However, there are other very urgent solid waste needs that must be addressed, and they request that these funds be made available to help comply with their Consent Agreement with the Department of Health and to help implement measures to increase diversion from both the Hilo and Pu'uana'hulu landfills. Provides background information and requests that \$125,721 be used to restore four positions that were cut in preparation of their proposed budget; \$112,500 will be used to provide greenwaste collection centers at eight North and East Hawai'i transfer stations; and \$125,000 will be used to begin development of a Material Recovery Area at the Pu'uana'hulu Landfill.

MANAGEMENT SOLID WASTE DIVISION

From Finance Director William Takaba, dated July 21, 2004, transmitting the above resolution. The current staffing level at the South Hilo Sanitary Landfill is unable to provide adequate maintenance activities and waste capacity efficiency. The creation of these positions will help to conserve airspace at the landfill, will increase compaction of waste, and will reduce environmental liabilities relative to litter control, storm water management, and the hazardous waste exclusion program. Thus, extending the life span of both County landfills and increasing landfill efficiency which will minimize the County's risk of future environmental contamination and associated regulatory violations.
