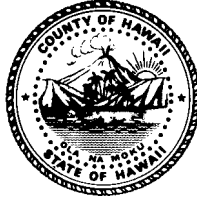

Comm. 315: A BILL FOR AN ORDINANCE AMENDING SECTION 15-68.1, HAWAI'I COUNTY CODE, PARKS AND RECREATIONAL FACILITY SCHEDULE- PARKS, KOHALA, BY RENAMING THE SAMUEL M. SPENCER BEACH PARK – "SPENCER PARK AT 'ŌHAI'ULA BEACH" AND THE PAVILION AT 'ŌHAI'ULA – "SAMUEL MAHUKA SPENCER PAVILION"
