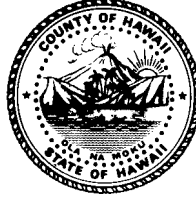

Bill 262: AN ORDINANCE AMENDING CHAPTER 24 OF THE HAWAI'I
(Comm. 756) COUNTY CODE 1983 (1995 EDITION), RELATING TO VEHICLES AND
TRAFFIC, TO ESTABLISH PARKING ZONES AT THE AUPUNI CENTER
(Setting the new 8-hour parking meter zone at the Aupuni Center parking lot fronting
Kilauea Avenue, at the rate of twenty-five cents per two-hours, and setting the new
two hour parking areas at the Aupuni Center along the northwest (Pauahi Street) and
southwest (Kilauea Avenue) sides of the Aupuni Center Building

Comm. 7: FLOODING CONCERNS OF DAN A. COLE
Letter to Councilman James Arakaki from Dan A. Cole, dated November 18, 2002,
bringing to his attention a potential flooding disaster waiting to happen in his district.
States, as a result of Flood Debris Removal Project P-3535, the Palai Stream bed
between Kīlauea Avenue and Kino'ole Street, was filled in and the stream path
altered. Informs that this has been confirmed by information obtained from the Hilo
office of the Natural Resources Conservation Service. Transmits a letter from the
Public Works Department dated February 20, 2002, which identifies the area of
concern and the debris in the stream bed, and hopes the hazard can be corrected
before damage occurs.
