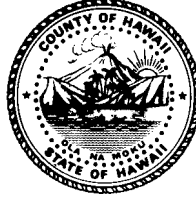

(Bill 55) AN ORDINANCE AMENDING CHAPTER 24, OF THE HAWAI'I COUNTY CODE 1983 (1995 EDITION), RELATING TO VEHICLES AND TRAFFIC (by installing a Yield sign along Kahoia Street at Bridge No. 26-5 in Honoli'i)

- From Public Works Director Bruce C. McClure, dated February 4, 2003, transmitting the above bill because the roadway width at this location is not quite wide enough to accept two-way traffic across the bridge. Width of the roadway at the bridge is approximately 16'.
