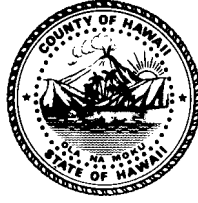

Comm. 214: AN ORDINANCE AMENDING CHAPTER 24 OF THE HAWAI'I COUNTY
(Bill 96) CODE 1983 (1995 EDITION) RELATING TO VEHICLES AND TRAFFIC
(Lowering the existing 35 mph speed limit on portions of Kawaihae Road to
30 mph)
From Director of Public Works Bruce C. McClure, dated April 10, 2003,
transmitting the above bill. The amendment will improve overall traffic safety
along Kawaihae Road, from Lindsey Road to an area where Kawaihae Road
enters State jurisdiction. The South Kohala Traffic Safety Committee concurs

Comm. 225:
(Res. 66-03) RESOLUTION ADOPTING WOOD VALLEY ROAD IN KA‘U AS A COUNTY ROAD TO MAINTAIN IN PERPETUITY
From Public Works Director Bruce C. McClure, dated April 23, 2003, transmitting the above resolution. This resolution is being proposed for the following reasons: FEMA will pay 75% of the cost to repair the November 2000 flood damage (approximately \$1,000,000) only if the County passes a resolution to maintain the road in perpetuity; Wood Valley Road is the only road in and out of Wood Valley, a community of about 50 homes, and the only connection to County-owned roads within Wood Valley; no one is currently maintaining Wood Valley Road; the only repairs to the road stem from emergency situations when the County Civil Defense deems it imperative for County forces to make the road passable; and a section of the road is a government road.

Recommend adoption of Res. 66-03.
