From Keith Unger and Eric von Platen Luder, Owners, Alii Gardens Marketplace, dated March 26, 2004, requesting a sign variance on the size of their signs to 3' x 6', which they feel would make the signs more in scale with the physical size of their property.

They feel the signs should be larger than the sign ordinance calls for, in that motorists would benefit by being able to identify the property in ample time, in order to avoid "turn arounds."
