In anticipation of receiving this grant, \$52,000 has already been appropriated within the FY2005-2006 Operating Budget.

(Bill 181) AN ORDINANCE TO AMEND ORDINANCE NO. 05-86, AS AMENDED, THE OPERATING BUDGET FOR THE COUNTY OF HAWAI'I FOR THE FISCAL YEAR ENDING JUNE 30, 2006 (appropriates an additional \$60,364 into the Hawai'i County Police Department's Speed Enforcement Grant account)
From Finance Director William Takaba, dated November 14, 2005, transmitting the above bill. The State Department of Transportation Public Affairs - Safe Community Program has authorized a \$110,364 Speed Enforcement Grant to the Hawai'i County Police Department. The goal of this grant is to reduce the number of motor vehicle collisions resulting in injuries and fatalities caused by speeding drivers. In anticipation of receiving this grant, \$50,000 has already been appropriated within the FY2005-2006 Operating Budget.
Recommends passage of Bill 181 on first reading.

(Bill 182) AN ORDINANCE AMENDING ORDINANCE NO. 05-87, AS AMENDED, RELATING TO PUBLIC IMPROVEMENTS AND FINANCING THEREOF FOR THE FISCAL YEAR JULY 1, 2005 TO JUNE 30, 2006 (adds the Left-Turn Pocket at Palani Junction project for \$300,000)
From Finance Director William Takaba, dated November 14, 2005, transmitting the above bill. This project, which was initially appropriated at \$1 million within the Approved FY2004-2005 Capital Budget Ordinance No. 04-75, is in need of this supplemental appropriation as the apparent low bid is slightly higher than what was originally estimated. This project involves the design and construction of a left-turn pocket on Route 190 to channel the traffic turning into Route 180, and it should improve the movement of traffic through this intersection.
Recommends passage of Bill 182 on first reading.
- Comm. 560:
(Res. 213-05) RESOLUTION TO AMEND RESOLUTION NO. 97-05 BY INCREASING THE SQUARE FOOTAGE OF OFFICE SPACE IN THE DEPARTMENT OF RESEARCH AND DEVELOPMENT'S KONA OFFICE (increases the square footage of office space from 1,025 to 1,225 at the Lanihau Professional Building)
From Finance Director William Takaba, dated November 14, 2005, transmitting the above resolution. On June 1, 2005, the County Council adopted Res. 97-05, which authorized the multi-year lease for office space at the Lanihau Professional Building in Kona. Since that time, an additional 200 square feet of adjacent office space has become available, and the department wishes to include it as part of its total office space. The monthly rates per square feet are unchanged.
Recommends adoption of Res. 213-05.

(Res. 214-05) RESOLUTION AUTHORIZING THE PAYMENT OF FUNDS OF A LATER FISCAL YEAR AND OF MORE THAN ONE FISCAL YEAR FOR A MULTI-YEAR LEASE OF A COPIER FOR THE HAWAI'I COUNTY POLICE DEPARTMENT (a five-year lease for one copier for the Captain Cook Police Substation)
From Finance Director William Takaba, dated November 16, 2005, transmitting the above resolution. Their current copier is not working and the cost to repair it exceeds the annual cost to lease a new machine.
Recommends adoption of Res. 214-05.

(Res. 215-05) RESOLUTION AUTHORIZING THE ACCEPTANCE OF A MONETARY DONATION OF \$4,250 TO THE HAWAI'I COUNTY FIRE DEPARTMENT (from Wal-Mart Kona); and

Comm. 564:
(Bill 185) AN ORDINANCE AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS OF THE COUNTY OF HAWAI'I FOR THE PURPOSE OF FUNDING ALL OR A PORTION OF THE COSTS OF VARIOUS IMPROVEMENT PROJECTS FOR THE COUNTY AND THE DEPARTMENT OF WATER SUPPLY; FIXING THE FORM, DENOMINATIONS, AND CERTAIN OTHER DETAILS OF SUCH BONDS AND PROVIDING FOR THEIR SALE TO THE PUBLIC; AND AUTHORIZING THE TAKING OF OTHER ACTIONS RELATING TO THE ISSUANCE AND SALE OF THE BONDS AND THE RETIREMENT OF THE BONDS TO BE REFUNDED (authorizes the issuance of up to \$50 million in general obligation bonds of the County of Hawai'i for various projects for the Departments of Environmental Management, Parks and Recreation, Fire, Police, Public Works, and Water Supply) From Finance Director William Takaba, dated November 18, 2005, transmitting the above bill. Of the \$50 million in general obligation bonds, \$25 million is included for the Department of Water Supply (DWS). The DWS will reimburse the General Fund for its share of the debt service on the bonds and the cost of issuance. Currently, there are a number of high priority projects that are ongoing or ready to initiate which require funding within the next six months to continue, such as construction to meet legal mandates, repairs to facilities, expansion and replacement of facilities, new facilities, and road and traffic improvements (see Exhibit A). Also attaches Exhibit B, Current Debt Service Obligations for Bonds; and Exhibit C, Debt Service Projection.
Recommends passage of Bill 185 on first reading.
