From Mayor Harry Kim, dated December 7, 2004, requesting the Council's favorable recommendation of the above reappointment. Mr. McClure has served as the Director of Public Works from December 2002 to the present. Prior to then, he was employed by the Department of Water Supply of the County of Hawai'i from 1998 to 2002. From 1984 to 1990, he served as the Deputy Chief Engineer for the County of Hawai'i, and from 1990 to 1993, was the County's Chief Engineer. He has also worked for the State Department of Transportation. If confirmed, Mr. McClure will serve a term co-terminus with the Mayor, which will end on December 1, 2008.
