From Mayor Harry Kim, dated June 21, 2005, requesting the Council's approval of the appointment of the above individuals to the County of Hawai'i Transportation Commission.

*Ms. Kate Ahia (Council District 2) is a 59-year resident of Hawai'i. She is presently the Coordinator of the Hilo Pier Greeting Project, and states that she is not affiliated with any political party. If confirmed, Ms. Ahia will serve a term to expire on December 31, 2009, replacing Robert Kawakone, whose term expired on December 31, 2004.*

*Mr. Michael Sumja (Council District 9) is a 7-year resident of Hawai'i. He is currently retired from the California State Department of Parks and Recreation, where he was employed as a Ranger. Mr. Sumja states that he is a Democrat, and if confirmed, he will serve a term to expire on December 31, 2006, replacing Mr. Peter Hoffmann, who resigned when he was elected to the Hawai'i County Council.*

Comm. 306: STATUS REPORT ON MAJOR ROAD PROJECTS IN WEST HAWAI'I (on traffic mitigation, connector roads, and improvements to north-south traffic flow)
