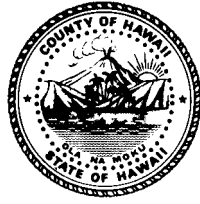

Comm. 717: **AN ORDINANCE TO ESTABLISH AN OPERATING BUDGET FOR THE COUNTY OF HAWAI'I FOR THE FISCAL YEAR JULY 1, 2006 TO JUNE 30, 2007**  
(Bill 235)  
From Mayor Harry Kim, dated March 1, 2006, transmitting for consideration the proposed Operating Budget for the Fiscal Year 2006-2007, totaling \$316,076,272 in estimated revenues and appropriations (Part I-Volume I), and includes the operations of eleven of the County's special funds as well as the general fund. Discusses Real Property Tax, Affordable Housing, Reserves; and Other Budget Highlights to include Improving Parks and Recreation Services, Improving Public Safety, Speeding up Building Permits, Expediting Capital Improvement Projects, Improving the island's environment, Expanding Mass Transit Services, and Enabling Departments to carry out Fair Labor Standard Act requirements. Includes tables showing budgeted expenditures for FY 05-06 and proposed expenditures for FY 06-07; and projected revenues for FY 06-07, listing significant changes to revenue sources. Also submitted is the Operating Budget Proposal Part I-Volume II, which describes departments and their programs, program objectives, highlights, program measures, expenditures and positions.

 (Bill 236)  
 From Mayor Harry Kim, dated March 1, 2006, transmitting for consideration the proposed Capital Budget (CIP) for FY 2011-12, and the Capital Program for the next six years from Fiscal Year 2006-07 to 2010-11(Part II), consisting of 63 projects totaling \$77,270,000 of which \$3,200,000 is Federal Grants Receivable and \$74,070,000 is County-financed through State Revolving Fund loans, bonds, or other sources. 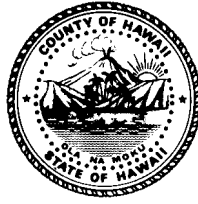

Notice to Lobbyists: If you are a lobbyist, you must register with the Hawai'i County Clerk within five days of becoming a lobbyist {Article 15, Section 2-91.3(b), Hawai'i County Code}. A lobbyist means "any individual engaged for pay or other consideration who spends more than five hours in any month or \$275 in any six-month period for the purpose of attempting to influence legislative or administrative action by communicating or urging others to communicate with public officials." {Article 15, Section 2-91.3(a)(6), Hawai'i County Code} Registration forms and expenditure report documents are available at the Office of the County Clerk-Council, 25 Aupuni Street, Hilo, Hawai'i 96720.
